DF highlighted the positive data results (phonics, maths, EYFS) showing the interventions in place are working. Overall school data shows attainment is still mixed but progress is being seen.

Teacher assessment data used in the report as opposed to test result data. To be confirmed by end of T6.

Governor Question: SATS year 2 being dropped from 23-24?

Yes, internal assessments used instead.

Governor Question: where are the future assessment points across school?

Reception baseline data & outgoing KS2 results will be used as comparison. Phonics & timetables will remain.

Staff updates – Andy Quinton leaving for a deputy head role. His replacement has been recruited.

Governor Question: we are losing 2 English leads? Is this an issue?

Heidi Paton remains in post as core link, a further 2 members of staff have been appointed with strong English skills & handovers taking place with AQ & SJP. New KS1 lead is English specialist.

T6 Events have been circulated to all Governors.

Governor Comment: pressures from lack support from external agencies & in particular how that impacts staff. Governors who work in other schools confirmed that this was also the picture in other authorities.
